WOULD ALL PLAYERS PLEASE READ AND BE AWARE OF ALL KNOCKOUT RULES FOR ARRANGING MATCHES. BOTH PARTIES MUST MAKE CONTACT WITHIN 7 DAYS OF RELEASE DATES. IF PLAYERS CAN'T MUTUALLY AGREE A SUITABLE DATE THEN THE HOME PLAYERS MUST SUPPLY 3 MATCH DATES, NOT ALL CAN BE THE SAME WEEK OR THE SAME NIGHTS, AND ONLY ONE CAN BE A WEEKEND.

KNOCKOUT COMPETITIONS RULES & GUIDELINES (SUMMARIZED)

KNOCKOUT DRAWS

The Knockout competitions will be re-drawn round by round, and will be posted on the league website: www.lincolnpool.co.uk

Players and venues may also receive copies of the draw sheets via Email, WhatsApp & Messenger.

Venues are required to print off and display a copy of the latest draw sheet and the full version of the knockout rules for their players.

Please check the league website for the latest up to date draws as byes may be filled & matches changed subject to printing errors or omissions.

The complete and up to date knockout competition rules and guidelines are available to view and download on the league website.

ARRANGING MATCHES

Both parties must make contact within 7 days of release dates to arrange matches. If players can't mutually agree a suitable date then the home players must supply 3 match dates, not all can be in the same week or the same nights, and only one can be a weekend.

Match times to be proposed by the home venue player, but weekday matches (Monday to Friday) may only be arranged for evenings only (7pm – 9pm) unless both players mutually agree a daytime or different start time.

Failure to make contact by either player, or failure to follow all rules and guidelines will result in elimination.

Please note that just telephoning venues and asking for opponents does not constitute contact, please leave your contact details and match dates in writing, on social media or contact opponents directly.

Should either party not arrive within 30 minutes of the agreed start time, then the non-offending party may submit a claim for the match.

All matches up to and including the semi-finals are to be played at the home players venue as drawn.

The home players are responsible for the availability, cost and preparation of the home venue match table.

In all League and Knockout competitions only 7' x 4' tables, with 2" red and yellow balls (as per rule 14) are permitted to be used for matches.

In the interest of sportsmanship please be tolerant towards players who may work shifts, play on another night or be on holidays during the season, and try to be flexible on dates and times of matches.

No extensions past the closing date will be granted except in very exceptional circumstances only and where all Knockout rules have originally been followed. Extensions will not be granted for longer than 7 days after the closing date, and no players will be granted more than one across all competitions during a season. Requests for extensions cannot and will not be accepted on or after the advertised closing date.

Holidays, non-contact and ignorance of the knockout rules and guidelines are not exceptional circumstances.

SINGLES & SCOTCH DOUBLES KNOCKOUT COMPETITIONS

Lincoln Singles, Seniors Singles and Ladies Singles matches are to be played over the best of 7 frames up to and including the semi-finals, and Finals are to be played over the best of 9 frames.

Blackball Singles matches are best of 9 frames up to and including semi-finals, Final is best of 11 frames.

Doubles Knockout matches are best of 5 frames up to and including semi-finals, Final is best of 7 frames.

Toss of a coin (or lag if both players prefer) for first break, alternate breaks thereafter.

In Scotch doubles both players must alternate breaks, the same player cannot break every time.

Doubles players must not confer when it is their turn at the table, and must not coach or advise whilst either

player is in control of the table, except following the break when players may only confer regarding choice of colour group, (see rule 3k).

TEAM KNOCKOUT

Team Knockout matches are played over the best of 9 frames, consisting of a 4-man scotch team frame, 2 scotch doubles frames, another 4-man scotch team frame, and 4 singles frames, to be played in that order. If the scores reach 4-4 then a final deciding scotch team frame is played, with toss of coin (or lag if both players prefer) for break.

Teams may play with between 4 and 12 registered team ko players.

Away teams to fill in the result sheet first and submit it to the home team's captain for pairing. Once a result sheet is filled in the players and playing order cannot be altered without the opposing captains permission.

Home teams break first, alternating breaks thereafter, as indicated on the result sheets.

Scotch Doubles and Scotch Team players may not coach or advise the player at the table, except following the break when players may only confer regarding choice of colour group, or while it is still an 'open table'.

New player registrations accepted as per current league rules, subject to not having been registered or played for another team or expelled.

FINALS

The finals of all Knockout competitions will be played at specially selected venues on specific dates and times as designated by the committee.

Should players mutually wish to change a specified final date they must contact and obtain approval from the Knockout Secretary.

RESULTS & CLOSING DATE

Match results are the responsibility of the winners and can be submitted in either of 2 options -

1) By text or WhatsApp to 07765 662647, 2) By email to: kosecretary@lincolnpool.co.uk

Please include player names, competition, and match result in frames.

* For Team Ko matches please send a clear and legible copy of the result sheet via email or WhatsApp in (see rule A11).

Results and Claims must be received within 48 hours of the closing dates, which are clearly displayed on Ko draw sheets & the league website.

Failure to submit a result or claim on time will result in automatic elimination from competitions.

PLEASE REMEMBER: Playing matches on live streams, posting results on Facebook or playing against or in front of committee members does not mean you don't have to submit the result yourself.

CLAIMING A MATCH

Claims can be made by the non-offending players stating why the match is being claimed such as 'failure to show up' or 'no reply to contact' and giving as much supporting facts and evidence as possible i.e., dates and times of contact, when and with whom messages left, when match was arranged for etc. Players must have attempted to make contact and complied with all the rules and guidelines to submit a valid claim.

If both parties claim a match the committee will decide the outcome and may set a date and time on which the match must be played, failure to attend by either party would result in elimination. All claims must be submitted as per match results above.

MISC. NOTES

All Knockout competitions must be completed before the seasons league presentation evening.

Any players expelled from the league, found to be not registered or not playing sufficient matches for their league team will be withdrawn from all ko competitions, no entry fees would be refunded.

Any players with outstanding fines or entry fees will not be eligible for any prize money won.

No concessions are made for players banned from or refused entry to venues for whatever reason, including age.

Unless otherwise stated above, normal league rules and administrative rules apply. The committee's decision in all matters is final.

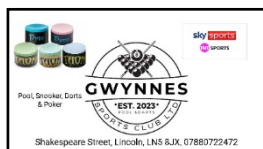

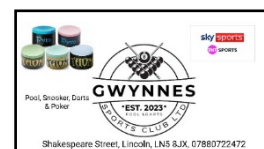
