Team Ko format best of 7 frames, consisting of 4 singles, 2 scotch doubles and a deciding 4 man scotch team frame.

Scotch doubles & team frames involve all players taking 1 shot each (not visit) in turn.

e.g. Team A at the table, Player 1 takes a shot, if he pots a ball player 2 takes a shot, and so on in turn thru all players.

until a player from Team A misses or fouls, then Team B plays in turn, and so on.

Players may not coach or advise the players at the table, except following the break off,

though players may confer when not at the table as per league rule 11.

Toss of coin for first break, or lag if both players prefer, alternate breaks thereafter.
